SERVICE AGREEMENT

AGREEMENT made this _____ day of _____ 20____, between djdiscjockey.com and _____ (herein after called "Client").

- 1) djdiscjockey.com will furnish and the Client will accept, for the engagement described herein, the services of Disc Jockey Entertainment. The services shall be provided on a continuous basis during the stated hours of said engagement.
- 2) It is agreed that djdiscjockey.com executes this agreement as an independent contractor and is not an employee of the client.
- 3) A deposit of \$150.00 is to be paid upon execution of this agreement, with balance due immediately following the end of said engagement. Deposits are non-refundable.
- 4) djdiscjockey.com shall at all times have complete supervision, direction and control over the services provided at this engagement and expressly reserves the right to control the manner, means, and details of the performance of services, as well as the ends to be accomplished.
- 5) Client agrees to the rate of \$_____ for _____ hours. Additional hours will be billed at \$75.00 per hour at the discretion of djdiscjockey.com, and must be paid prior to additional performance time.
- 6) In the event of circumstances deemed by djdiscjockey.com to present a threat or implied threat of injury to djdiscjockey.com or any property in djdiscjockey.com's possession, djdiscjockey.com reserves the right to cease performance. Client shall be responsible for payment in full, regardless of whether the situation is resolved and/or performance continues. It is also understood and agreed that the Client agrees to provide crowd control if warranted at the Client's expense. Client shall be deemed responsible and liable for any loss or damage to any property belonging to djdiscjockey.com that is caused by Client and/or guests, customers, students, etc.
- 7) Client grants djdiscjockey.com unconditional release of the use of names, photographs, or audio/video recordings taken at event herein for djdiscjockey.com advertising and/or promotion.
- 8) Client shall furnish djdiscjockey.com with an eight foot table with proper skirting, and a reliable power source within 30 feet of said table. In the event of an outdoor function, Client shall be responsible to provide adequate protection from the elements. Outdoor events will be suspended during any electrical storm to prevent damage to equipment and/or guests.
- 9) Events canceled within 45 days of the event are subject to a 100% cancellation fee.
- 10) This agreement shall be considered to have been made in the State of Michigan, and shall be interpreted, and rights and liabilities determined, in accordance with the laws of said State.
- 11) This contract constitutes the entire agreement between Client and djdiscjockey.com. It may not be modified unless amended in writing and signed by the parties hereto.
